Moved by Fischer, Warner seconded, to approve Monday, August 29, 2022, 6:30PM Special Meeting to go over 2023 Appropriations and 1st Reading thereof – AND- to approve Monday, September 12, 2022, regular meeting for 2nd Reading, Adoption & Approval for Publication of same. All members present voted Aye. Motion carried.

Appointment: Larry Zebroski – Code Enforcement

Zebroski spoke to council with concerns/questions he had with the current code enforcement regarding licensing of vehicle on his property and abandoned building liability within the community. Discussion.

Appointment: Steven Zuber, EMT Director

Discussion was had regarding the EMT staff being short-handed and a need for ideas/solutions to attract more EMTs to take the course and become a part of the staff.

Voting at Large was discussed further. Schatz is doing further research on circulation of petition protocol and timeframe and will report back to council.

Mayor Wuttke will be calling Attorney Sovell regarding a new city attorney recommendation. Code Enforcement on the Vail Building is being worked on and will continue to be worked on.

SMS Texting Programs were discussed. It was decided that the cost per year is too high for the amount of use it would get in sending out various non-emergent text messages from the city, and the city website and Facebook page are currently available. Fiscsher stated he could look over the research information further.

Schatz informed that the medical cannabis license form is available at the city in case an inquiry is made.

Mayor Wuttke discussed any possible interest in getting the Community of Gettysburg involved with the Keloland Live Cam. Discussion. It was decided that it was not of interest at this time.

Moved by Nagel, Warner seconded, to approve the Finance Office and Fire Hall outdoor awnings to be repaired/replaced in which Economic Development will be paying one-half of the total cost. All members present voted Aye. Motion carried.

Discussion was had regarding upcoming special meeting for 2023 budget and recommendations regarding funds available for the upcoming 140th Celebration. Extra garbage dumpsters and police force were discussed.

Mogard gave police report. Mogard stated they will be attending several trainings in the near future. Mogard also explained that Carfax has a new accident reporting system in place for police which the department will be utilizing.

There was one fuel bid from Agtegra for the following: Unleaded 10% Ethanol FTE \$3.965, Ruby Fieldmaster at \$4.58, Aviation Gas at \$5.77, and Jet-A at \$4.70. Moved by Fischer, Ellwanger seconded, to accept the fuel bid from Agtegra. All members present voted Aye. Motion carried.

Schatz stated the city has again received a Drinking Water Certificate of Achievement Award this year. Schatz asked permission to quote the DENR correspondence within the minutes. Moved by Warner, Ellwanger seconded, to approve including the DENR Drinking Water Certificate of Achievement Award and information within the minutes. All members present voted Aye. Motion carried.

Department of Agriculture and Natural Resources (DANR) recognizes City of Gettysburg for Drinking Water Compliance. PIERRE – The South Dakota Department of Agriculture and Natural Resources (DANR) announced today that the City of Gettysburg public water system and the system's operation specialists have been awarded a Drinking Water Certificate of Achievement Award.

"Access to safe and reliable water sources is essential to keeping our families safe and our economy growing," said DANR Secretary Hunter Roberts. "This award is a testament to the hard work and dedication of South Dakota's drinking water system operators and their efforts to ensure their customers have access to clean drinking water."

The system's operation specialists are Greg Gerber and Allen Pope.

To qualify for the Drinking Water Certification of Achievement Award, public water systems and their system operations specialists had to meet all of the compliance monitoring and reporting requirements, drinking water standards, and certification requirements for 2021.

Schatz reported that (2) more bucket swings as well as an infant/toddler swing have been purchased for Little Angel's Park. Two new sets of poles and nets were also purchased to replace at both the city park tennis courts. Discussion was had that pickle ball lines can be put on the tennis courts as well as the tennis lines so both sports can be played. Fischer stated he will work with the city maintenance crew to get the pickle ball lines epoxied on. Discussion was also had on possibility of purchasing 1 or 2 Expression Swings, (1) for each park. Moved by Ellwanger, Warner seconded, to approve the purchase of (2) Expression Swings {a/k/a Mommy & Me Swings}, (1) for each city park, pending the availability of date for delivery to be able to install and utilize yet this season. All members present voted Aye.

Schatz gave finance office report.

Moved by Ellwanger, Nagel seconded, to accept ambulance write-offs in the amount of \$2,632.75. All members present voted Aye. Motion carried.

Moved by Ellwanger, Warner seconded, to approve (2) water deposit refunds in the total amount of \$200. All members present voted Aye. Motion carried.

Schatz mentioned it is that time of year again for city employee annual reviews. Nagel will discuss an upcoming date and time with VanBockel, and Schatz will get set up accordingly.

Moved by Warner, Nagel seconded, to approve putting Pool Season Closing Date and Pool Fun Day ad in newspaper. The pool will not be having any evening open swim sessions in August due to lifeguards returning to school and sports practices. All members present voted Aye. Motion carried.

The city pool committee would like to have a short meeting with all pool personnel to discuss how the season went and go over pros/cons, concerns, issues, and ideas. Schatz will get a date and time set up for same.

Schatz explained the Bank of the West handout. Moved by Fischer, Nagel seconded, to approve allowing Mayor Wuttke to sign form from Bank of the West regarding a new checking account perks package they are offering for any full-time city employee, if interested, at no cost to the city. All members present voted Aye. Motion carried.
