Moved by Archer, Fischer seconded, to approve current purchases needed in the sewer department out of the 2023 budget (sewer jet pump, lagoon pump, lagoon chemical, and safety gas monitor). All members present voted Aye. Motion carried.

Moved by Nagel, Ellwanger seconded, to approve earmarking \$25,000 per year for a 5-year period (2024-2028) toward purchase of a new police squad. All members present voted Aye. Motion carried.
