

Pursuant to the due call and notice thereof, the City Council met in special session on June 18, 2025, at 12:00PM at the City Finance Office in Gettysburg, SD and via ZOOM. Present at the meeting were Adam Roseland, Michael Fischer, Cyle Phillips, Bill VanderVorst, and Seth Warner (Zoom). Also present were David Mogard, Chief of Police, Greg Gerber, Maintenance Supervisor, Sheila Schatz, Finance Officer, Brooke Edgar & Bob Babcock, Helms & Associates, Jamie Arneson, RDO Equipment, Chance Jandel, Butler Machinery, and a few other participants via Zoom.

Moved by Fischer, VanderVorst seconded, to approve June 18, 2025, proposed agenda. All members present voted Aye. Motion carried.

Moved by VanderVorst, Fischer seconded, to table approving the June 2, 2025, regular council meeting minutes until July 7, 2025, regular council meeting. All members present voted Aye. Motion carried.

Moved by Fischer, VanderVorst seconded, to go into Executive Session for legal and personnel at 12:09PM. All members present voted Aye. Motion carried. The Council reconvened at 12:29PM.

Two sealed bids for "Three Articulated, 4-Wheel Drive Loaders and Attachments for De Smet, Gettysburg, and Philip Airports" were presented and opened from RDO Equipment Company and Butler Machinery Company. Moved by Fischer, VanderVorst seconded, to accept and award the lower bid submitted from RDO Equipment Company for "Three Articulated, 4-Wheel Drive Loaders and Attachments for De Smet, Gettysburg, and Philip Airports" for the City of Gettysburg in the following amounts of: Bid Schedule B - \$230,174.00, Alternate Bid #B1 - \$77,717.00, Alternate Bid #B2 - \$6,095.00, Alternate Bid #B3 - \$23,070.00, Trade-In B (Base Bid Deduct) - \$42,250.00, for total of Bid Schedule B for City of Gettysburg in the amount of \$294,806.00. All members present voted Aye. Motion carried.

Moved by Fischer, Phillips seconded, to approve Mayor to sign contract documents upon FAA approval of the Buy American Waiver on the bid for "Three Articulated, 4-Wheel Drive Loaders and Attachments for De Smet, Gettysburg, and Philip Airports". All members present voted Aye. Motion carried.

Approval of Mayor to sign grant application and grant agreement on "Three Articulated, 4-Wheel Drive Loaders and Attachments for De Smet, Gettysburg, and Philip Airports" – Not needed, so no action taken.

Moved by Fischer, VanderVorst seconded, to approve hiring Nathan Dennis as a full-time police officer for the City of Gettysburg, currently non-certified, for the starting wage of \$21.00 per hour with a 3-year contract to be drawn up by City Attorney Vogel regarding receiving pay while attending police academy. All members present voted Aye. Motion carried.

Moved by VanderVorst, Fischer seconded, to approve having a free swim day at the City swimming pool on June 28, 2025, during the Annual Car Show Event and several other events within the City during normal, regularly scheduled pool hours. All members present voted Aye. Motion carried.

Mayor Roseland asked if any of Council were interested in attending the Elected Officials Workshop in Pierre, SD on July 16-17, 2025. No one responded "yes".
